## STALCRAFT: X COSPLAY CONTEST REGULATIONS

#### **PREAMBLE**

This set of Rules (hereinafter referred to as the "Rules") defines the procedure for holding a STALCRAFT: X event called "Cosplay Contest" (hereinafter referred to as the "Contest") and is an additional agreement to the STALCRAFT: X Game (hereinafter referred to as the "Game") Licence agreement in force as of 11.09.2024 (hereinafter referred to as the "Licence agreement").

This set of Rules is referred to global regions of the STALCRAFT: X Game. Global regions are Europe (EU), North America (NA), Southeast Asia (SEA). All the regions are combined by one name, "GLOBAL" ("GL" for short) which will be used in this document to designate the above listed regions.

The Organiser does not charge a fee for participation in the Contest.

## WHY IS IT IMPORTANT TO READ THE CONTEST RULES

Please read this Rules carefully. They will not only tell you more about how to participate in the Contest and the criteria for judging the winners, but will also help ensure that the Contest is run in a safe and comfortable environment for all Participants.

By submitting an Application Form and entering the Contest, you confirm that:

- you've read all the Rules, agreed to all the terms and conditions presented herein and agree to abide by them.
- you have reached the age of legal capacity in accordance with the laws
  of the applicable legislation to accept the terms of the Rules and
  participate in the Contest. OR
- you have previously obtained all necessary consents (including parental/legal representative consent) in accordance to laws of the applicable legislation to accept the terms of the Rules and participate in the Contest.
- you provided consent to the collection and processing of personal data (independently or on behalf of a legal representative).
- you have an account on the website at the time of the Form submission that is required to access the Game.
- you are a user of the Game in accordance with the Licence agreement.

The Contest Organiser is unable to further verify the age of each Participant, and therefore relies only on the information provided by the Participant themselves and their good faith in obtaining the necessary consents and permissions.



In this regard, the Organiser presumes that each Participant is legally capable or acts with the consent of their legal representatives, and is not responsible for the Participant's actions in case the latter violates the terms of the Rules on prior obtaining the necessary consents and authorizations for participation in the Contest.

If you are not sure that you've reached the sufficient age to participate in the Contest, please address a professional lawyer or attorney.

## **DEFINITIONS**

- Participant respective individual (You), acting only on their own behalf independently upon attaining legal capacity in accordance with applicable law or on their own behalf on the basis of appropriate consents from legal representatives in case of not reaching the age of legal capacity, who has submitted the Form for participation and who is a User of the Game in accordance with the Licence Agreement.
- Application Form a written voluntary expression of the Participant's desire to participate in the Contest, expressed by filling out the Participant Form. Participant Form can be found here: <a href="https://forms.gle/R9Y4J24scnuovPPH8">https://forms.gle/R9Y4J24scnuovPPH8</a>.
- **Contest** Cosplay Contest, the event dedicated to the Game and organised by "Exbo North" LLC, with Physical and Digital Prizes.
- "RED EXPO" Convention a convention dedicated to various games organised by "IT News" LLC. Detailed information about the convention, and its attendance rules, can be found here: <a href="https://redgameexpo.ru/">https://redgameexpo.ru/</a>.
- Creative work an image created independently by the Participant for participation in the Contest, related to the Game, in accordance with the requirements of the Rules. The Creative work shall be provided in the format of high quality photographs depicting the Participant and shall be transmitted to the Organiser by indicating in the Form a link to cloud storage with such photographs. Creative work also means intermediate and other results of works provided by the Participant in the Form, made in the format of photos, videos, other works.
- Winner a Participant, whose Creative work was submitted in accordance with the Contest Rules and selected by the jury



- (Organiser) as the winning one, taking into account the criteria for evaluation of such works specified in the Rules.
- **Digital prizes** in-game prizes in the STALCRAFT: X Game as defined in the Licence agreement, issued to Participants in accordance with the Rules.
- **Physical Prizes** tangible items given to Winners in accordance with the Rules. The number and content of the Physical Prizes is determined unilaterally by the Organiser and may be changed without further notice to the Participants, Winners.

  - Information about the Contest is an integral part of these Rules and contains mandatory requirements for Participants, Creative works and the Contest.

# **ELIGIBILITY REQUIREMENTS**

- 1. How to participate in the Contest: The Participant must have reached the age of legal capacity or provide the necessary consent/authorization of legal representatives when submitting the Form.
- 2. Submission of Data: The Participant must provide current, correct and valid data when completing the Application Form and is solely responsible for any breach of this requirement.
- 3. Being part of the Game: The Participant must have an account to access the Game and be a user of the Game (number of playing hours is irrelevant).
- 4. Independent participation in the Contest: one Participant is entitled to submit one Form and one Creative work to the Contest.
- 5. Independent Creative work: the Participants must independently develop an image of appearance and accessories available for participation in the Contest. The use of assistance in making a designed outfit (e.g. atelier) is not refrained, handmade is encouraged.
- 6. Contest Compliance: Participant must comply with the Contest Rules, Licence Agreement, Privacy Policy, and the Resource Rules located on each resource in the designated areas (collectively, the "Resource Rules").
- 7. Observe all safety rules when creating your Creative works.



The Organiser is entitled to determine at their sole discretion whether an Entrant and/or their work meets the eligibility requirements for participation in the Contest and the requirements of the Rules in the absence of any discrimination on racial, religious, gender or other grounds.

# **CREATIVE WORKS REQUIREMENTS**

- 1. The character or creature chosen for the Creative work must embody a recognisable image from the Game and meet at least one of the nominations specified in the Rules.
- 2. The Participant may embody the image both as a costume and as characters or creatures from the Game, including mutants and game characters.
- 3. No cosplay of the original Stalker in any form will be accepted for evaluation of Creative works.
- 4. Creative work s supposed to be created specifically for the Contest. The Participant undertakes not to submit images/costumes/appearances to the Contest that have previously been entered in other similar Contests.
- 5. The Creative work produced/any part of it, including the title and description, must not contain:
  - 5.1. Materials that violate generally accepted standards of decency (including political, military propaganda, erotic, pornographic, extremist, nationalist, and other similar materials).
  - 5.2. Materials that violate the applicable laws, the laws of the country of the Participant's citizenship, the rules of the platforms on which the results of the Contest will be posted as a video in accordance with the Rules, as well as that contain an appeal to actions that violate the provisions of the laws, rules of the said countries and platforms.
  - 5.3. Materials that can substantiate or justify extremism, discredit the Armed Forces of the Russian Federation and other countries, contain propaganda inciting social, racial, national or religious discord, degrading national dignity, propagandising the exclusivity, superiority, or inferiority of citizens on the basis of their attitude to religion, social, racial, national, gender or linguistic affiliation, as well as propaganda, in the course of which propaganda and public demonstration of Nazi symbols are carried out.



- 5.4. Materials infringing the rights and interests of third parties, including intellectual rights.
- 6. More detailed requirements to Creative works are also specified in the Contest Information.

The Participant may receive an additional advantage in the Contest if they provide photo and video evidence of the process of creating their Creative work. These materials can be attached with the finished work in the Form.

The Organiser may unilaterally and at its sole discretion reject and not accept any Creative work for participation in the Contest without notifying the Participants and explaining the reasons.

## **GENERAL TERMS AND CONDITIONS**

- **1.1.** The contest will be held **since 07 November 2024 until 05 January2025** During this period, Participants may submit their Creative works in accordance with these Contest Rules.
- **1.2.** This Contest is open, aimed at socially useful purposes and pursues the following objectives: attracting young people to Creative Activity, assisting in the development of the creative potential of the Participants, popularising the game industry.
- **1.3.** Criteria for evaluation of Creative works are determined in accordance with the requirements specified in the Rules. The evaluation of the Creative works and the final determination of the Winners in this Contest shall be determined by a jury appointed by the Organiser.
- **1.4.** The jury is composed of "Exbo North" LLC employees, including the following positions: CEO, Art Director, Game Visualisation Producer. The Organiser has the right to change the composition of the jury at any time during the Contest or during the summing-up period.
- **1.5.** "Exbo North" LLC reserves the exclusive right to independently determine the Winners of this Competition in accordance with the Rules without necessarily providing an explanation.
- **1.6.** The Organiser may, at its sole discretion, disqualify a Participant if they violate any terms of the Rules, the Licence Agreement, the Privacy Policy, the provisions of applicable law and in other cases.
- **1.7.** The Organiser has the right to amend or waive individual terms and conditions of the Regulations at its discretion, unilaterally in accordance



with applicable law. The Participants are notified of changes by publishing a new version of the Rules by the Organisers that can be found here: https://exbo.net/legal/gl\_cosplay\_contest\_rules.pdf.

If the Participant does not agree to accept the amended edition of the Rules, they undertake to notify the Organiser by contact e-mail <a href="mailto:contact@exbo.net">contact@exbo.net</a> within 10 (ten) calendar days from the date of posting the new version of the Rules. Failure to give such notification after the expiration of the time limit shall be deemed acceptance by the Participant of the new version of the Rules.

Refusal to accept the new version of the Rules means refusal to participate in the Competition.

**1.8.** Winners will be contacted exclusively through emails with the domain @exbo.net. "Exbo North" LLC has no other email addresses except for the domains listed.

#### PARTICIPANTS AND WINNERS ARE PROHIBITED

- **2.1.** To disturb, interfere, or otherwise prevent other Entrants from participating in the Contest.
- **2.2.** To leave comments, use nicknames, send messages to other Contest Participants and people involved in the Contest, to the Organiser, in any offensive, threatening, obscene, defamatory and other unacceptable form.
- **2.3.** To violate any terms of the Rules, the Licence Agreement, the Privacy Policy, provisions of applicable law, breach of platform rules specified in clause 3.1. of the Rules.
- **2.4.** It is forbidden to use photo editing and video editing software to distort the actual appearance of the costume, including colour correction. The only possible solution is to crop the work around the edges, without distorting how the costume (the outward manifestation of the image) looks in reality.
- **2.5.** To transfer their Creative works to other Participants, including if for any reason the Participant is unable to participate in the Contest.
- **2.6.** To transfer the right to receive the Physical or Digital Prize to third parties, including relatives or friends, unless otherwise expressly provided for in the Rules.
- **2.7.** The Organiser has the right to monitor compliance with these Rules, monitor possible violations and apply appropriate measures at its discretion, including issuing warnings and disqualifying Participants.



## **CONTEST SUMMARISATION**

**3.1.** The Organiser shall summarise the results of the Contest within 20 (twenty) calendar days from the end date of the Contest.

- **3.2.** In the video, the Organiser will announce the Winners of this Contest and provide the necessary information about them.
- **3.3.** The guaranteed number of Winners receiving Physical Prizes is 9 (nine) Participants. The Organiser has the right to unilaterally and at its sole discretion to increase the number of Winners.
- **3.4.** The Winners receive Prizes depending on the places taken:

- **3.5.** To determine the Winners, the jury will evaluate the works according to the following criteria: compliance with the image, quality of performance, details, originality of the materials used, including:
  - **Compliance with the image:** The accuracy of recreating a character, suit, or creature from the STALCRAFT: X universe is evaluated.
  - Quality of performance and details of the image: Neatness of production using various techniques (sewing, 3D printing, painting, etc.) is important, as well as unique elements and interpretations that make the costume memorable and original.
  - **Photo or video quality:** The better the photos or videos, the easier it will be for us to objectively evaluate your work. It's not so much about



photoshop as it is about the quality of the shot and composition. Good photos can make up for minor flaws in the costume.

Additional criteria for evaluating the Creative work are also specified in the Contest Information.

- **3.6.** One Participant cannot win more than once in the same nomination.
- **3.7.** Contest results are published on the official resources dedicated to STALCRAFT: X game, including those mentioned in clause 3.1. of the Rules.

#### **DIGITAL PRIZES DELIVERY**

- **4.1.** Digital Prizes will be credited to the Winners' accounts within 14 (fourteen) days after the Contest ends and/or after the announcement of the Contest results. To receive them, the Winner has to activate the Prize through the in-game mail in the STALCRAFT: X Game.
- **4.2.** Digital Prizes are available to all Contest Participants, regardless of their citizenship and location.
- **4.3.** The Organiser may increase the number and/or add new Digital Prizes for Participants and/or Winners unilaterally and at its sole discretion.
- **4.4.** The Organiser is not responsible for the non-delivery of Digital Prizes in case the Participant provides incorrect data in the Form, including the character's nickname in the Game.

#### PHYSICAL PRIZES DELIVERY

**5.1** Physical Prizes are sent to the address provided by the Winner.

If delivery to the specified address is impossible for reasons beyond the Organiser's control, the Organiser will additionally contact the Winner at the contacts provided by the Winner to discuss the delivery of the Physical Prize or its replacement. If the Winner does not respond to the Organiser's request within 14 (fourteen) calendar days, they forfeit their right to receive the Physical Prize.

- **5.1.1.** To claim the Physical Prize, the Participant must answer the questions on the form to be sent by the Organiser via the contacts provided by the Winner in the entry Form within 10 (ten) calendar days of the deadline for results of the Contest.
- **5.2.** Responses must be submitted by the Winner within 14 (fourteen) calendar days of sending this form. If the Organiser has not sent a reply



form, the Winner must send the following details to <u>contact@exbo.net</u> themselves: Surname, First name, Middle name, convenient physical address and any other information necessary for delivery of the Physical Prize.

- **5.3.** If within 14 (fourteen) calendar days, the Winner fails to complete the form or provide the necessary and sufficient data for receiving and delivery to <u>contact@exbo.net</u>, the Winner forfeits the right to receive the Physical Prize. The Organiser reserves the right to dispose of such Prize at its sole discretion.
- **5.4.** The Winner must provide a valid address for delivery. If a false or incorrect address is provided, the Organiser is not responsible for delivery to that address and is not obliged to resend the Physical Prize to the other address.
- **5.5.** The Organiser is entitled to engage third parties to send the Physical Prize. The Organiser undertakes to deliver the Physical Prize to a carrier (to be determined by the Organiser) for delivery to the address specified by the Winner. Ownership of the Physical Prize is transferred to the Winner at the time it is delivered to the carrier. The risk of accidental loss or damage to such Prize shall also pass to the Winner at the moment of transfer to the carrier.
- **5.6.** Where applicable, the Organiser agrees to cover all taxes payable by the Winner upon receiving the Physical Prize. Otherwise, the Winner is responsible for paying the necessary taxes and fees associated with participation in the Contest and receiving the Physical Prize, if any.
- **5.7.** The Winner has the right to refuse the Physical Prize before providing personal data or within 5 (five) working days after providing it for delivery. A refusal must be sent to <a href="mailto:contact@exbo.net">contact@exbo.net</a> and is equivalent to a refusal of the Rules as far as the Physical Prizes are concerned.
- **5.8.** The Physical Prize for each Winner is a gift box with STALCRAFT: X game merch from the Organiser. The contents of the merch box are determined unilaterally by the Organiser and may vary in relation to the Winners and/or the nomination.
- **5.9.** The Organiser is not the manufacturer of goods that were created during the production of Game merch. The Organiser does not provide any warranty for the Physical Prizes and is not responsible for their quality and other properties. Any complaints about the quality of the Physical Prizes shall be directed to the manufacturer or distributor. The Organiser will provide the necessary contact data upon request, unless the dissemination of such data violates the privacy and other clauses of the agreements



between the Organiser and the manufacturer/distributor of the Physical Prizes.

**5.10.** The Organiser may increase the number and/or add new Physical Prizes for the Winners unilaterally and at its sole discretion.

#### LIMITATION OF LIABILITY

- **6.1.** The Organiser is not responsible for:
- **6.1.1.** Failure to receive emails or other documents from Participants on time, including cases caused by failure of email services, communication services, technical malfunctions or fraud in the Internet or communication channels used during the Contest period.
- **6.1.2.** Provision by the Player of incorrect data required for the Digital and Physical Prizes.
- **6.1.3.** Violation by the Participant of third party rights, including intellectual rights, violation of applicable law.
- **6.1.4.** Failure of Participants to read and understand the Rules and failure to familiarise themselves with the results of the Contest.
- **6.1.5.** As otherwise set out in the Rules, the Contest Information, the Licence Agreement, the Privacy Policy, the Resource Rules, the applicable law.

## **APPEAL**

- **7.1.** The Organiser has the right not to comment on the decisions made in relation to the Creative works and the results of the Contest.
- **7.2.** В случае возникновения спорных ситуаций, вытекающих из Правил, Участник вправе подать письменное мотивированное возражение путем его отправки на почту: contact@exbo.net не позднее 10 дней после подведения итогов Конкурса.
- **7.3.** Указанное письменное возражение в обязательном порядке должно содержать конкретные доводы и аргументы в отношении проведения Конкурса и положений Правил.
- **7.4.** The time limit for responding to a Participant's written appeal shall be ten (10) working days. If it is necessary to investigate the situation in more detail, the Organiser has the right to send additional requests to the Participant, as well as to extend the time limit for a response to clarify the circumstances.
- **7.5.** The Organiser reserves the right not to respond to the Participant's appeal if it is submitted in violation of the terms of this section of the Rules,



other clauses of the Rules, the Licence Agreement, the Privacy Policy, the Contest Information, and the Resource Rules.

#### INTELLECTUAL PROPERTY

- **8.1.** STALCRAFT: X game is a complex object of intellectual property, a computer game, which includes protected results of intellectual activity and means of individualisation, exclusive and other rights to which belong to the Organiser.
- **8.2.** The exclusive right to a Participant's Creative work belongs to the respective Participant.
- **8.3.** By submitting a Form and submitting the Participant's Creative work to the Contest (including any other materials submitted through the Form), the Participant grants to the Organiser a simple non-exclusive licence on a royalty-free basis with the right to sub-licence, without reporting, the Creative work in whole or in part, each intellectual property object included in the Creative work and other materials and objects submitted through the Form, for the entire term of the exclusive right of each such intellectual property object in the territory of countries all over the world by means of reproduction, communication to the public, inclusion in complex objects, creation of a compilation, collection or other derivative or composite work created on the basis of the Creative work and objects provided through the Form, and by other means provided by clauses 1270, 1317, 1324 of the Civil Code of the Russian Federation.
- **8.4.** By submitting a Form and submitting the Participant's Creative work for the Contest, the Participant gives consent to the Organiser and third parties and does not object to the use of their own name, creative pseudonym, nickname of the character of the Game, the name of the Creative work, if any, as well as gives consent and does not object to the use of the Creative work by the Organiser without indicating information on copyright and related rights (anonymous use), to make changes, abbreviations, additions to the Creative work, as well as allow the Organiser to use the Creative work in the Contest.

## PARTICIPANT WARRANTIES AND REPRESENTATIONS

**9.1.** The Participant agrees that the Organiser relies on the absolute validity and truthfulness of the Participant's warranties and representations when registering with the Contest Form, submitting the Creative work, and



agreeing to the terms and conditions of the Rules. The Participant's representations set out in this section of the Rules are representations of circumstances that are significant to the Organiser.

- **9.2.** The Participant hereby warrants and represents that at the time of filling in and submitting the Form the Participant has the right to participate in the Contest independently (the Participant is a legally capable person or has previously obtained all necessary consents and authorisations from their legal representatives).
- **9.3.** The Participant hereby warrants and represents that the Creative work submitted for participation in the Contest does not contradict the regulations of the Russian legislation and does not violate the intellectual and other rights of third parties. For the avoidance of doubt, the Participant warrants and represents that the Organiser is entitled to use the Participant's Creative work free of any encumbrances by third party rights.
- **9.4.** The Participant hereby warrants and represents that the Creative work submitted for participation in the Contest has not been previously submitted in other similar Contests at the time of submission of the Form.
- **9.5.** In the event of a Participant violating any of the warranties and representations set out in this section of the Rules, the Organiser reserves the right to disqualify such Participant.
- **9.6.** In the event of a Participant's violation of the warranties and representations specified in the Rules, such Participant assumes the obligation to independently settle and reimburse all losses and expenses of the Organiser related to claims or legal proceedings on third party claims and actions caused by such violation of warranties and representations.

## **PERSONAL DATA**

**10.1.** By submitting a Form, the Participant consents collecting and processing the personal data provided in the Form by the Organiser within the meaning of The General Data Protection Regulation (Regulation (EU) 2016/679), The California Consumer Privacy Act and other personal data legislation applicable to the Participant, including name, email address, nickname in the Game, as well as other personal data provided by the Participant to the Organiser in the course of conducting the Contest, summarising the results of the Contest and transferring the Digital and Physical Prizes.

Residents of the European Union are entitled to exercise all the rights provided for in Article 6 GDPR.



Residents of the State of California, USA, are entitled to exercise all rights provided by the CCPA. The Organiser hereby warrants that they do not sell personal data directly for reward.

- **10.2.** The list of actions with personal data to perform of which consent is given, without limitation: collection, recording, systematisation, accumulation, storage, clarification (update, change), extraction, use, transfer, including outside the EEA and the US (distribution, provision, access), to third parties (e.g. carriers) solely for the purposes of fulfilling the terms of the Rules, depersonalisation, blocking, deletion, destruction of personal data. Methods of personal data processing: mixed processing of personal data with the possibility of transmission via the Organiser's internal network and the Internet.
- **10.3.** The Organiser processes personal data of the Participants (users of the Game) in accordance with the Privacy Policy.
- **10.4.** The Organiser does not collect or process the personal data of the Participant of the special category.
- **10.5.** This consent is valid indefinitely until the Participant sends a written request for withdrawal of consent to the contact e-mail: <a href="mailto:contact@exbo.net">contact@exbo.net</a> or law@exbo.net.

#### **COSPLAY AT RED EXPO**

- **11.1.** The Organiser is a Participant of the RED EXPO convention.
- **11.2.** RED EXPO convention dates: 28.11-01.12.2024.
- **11.3.** The Organiser has prepared additional Prizes for the Participants who will visit RED EXPO convention and come to the Organiser's stand wearing cosplay (any image) dedicated to the STALCRAFT: X game.
- **11.4.** As an exception to the general regulations of the Rules, in order to receive additional Prizes, the Participant may visit the Organiser's stand not only in a self-made image and not only in an image submitted to the Contest as a Creative work, but also in any image/costume/appearance provided that it is a recognisable image from the STALCRAFT: X Game.
- **11.5.** Additional Prizes are awarded to each Participant who fulfils the conditions of this section of the Rules, namely promo codes for the Game. The Organiser independently determines the number and content of the Additional Prizes specified in this section of the Rules. The Organiser may increase the number and/or change and/or add new Additional Prizes for Participants unilaterally and at its sole discretion.



## **OTHER REGULATIONS**

- **12.1.** The law of the Russian Federation applies to the Rules.
- **12.2.** In the event of any disputes between the Participant and the Organiser in relation to this Contest, the Participant and the Organiser shall take all steps to resolve them by negotiation. If it is impossible to resolve the dispute through negotiations within 15 (fifteen) working days from the date of receipt of a request or claim by one of the parties, the dispute shall be referred to the court at the Organiser's location.
- **12.3.** If the Contest cannot be held due to technical failures, computer threats or other circumstances beyond the Organiser's control that prevent the Contest from being held, the Organiser may, at its sole discretion, cancel, suspend or change the terms and conditions of the Contest.
